THE PROJECTED ENROLLMENT FOR 22-23 BUDGET IS 195. CURRENTLY WE ARE AT 204 WITH 25 GRADUATING SENIORS. THE ENROLLMENT PROJECTION FOR 23-24 IS 205. THE BOARD APPROVED THE SECOND INTERIM BUDGET.
